Mary provided responses to the questions the Budget Committee had from the Public Hearing. See the attached page for questions and responses. Mary Knapp provided the committee with the SAU Payroll contract and the SAU Tuition contract. The tuition rate for the 2021 budget year is \$12,534 for students in grades 7-12. There was discussion regarding line 100 Wages of the 2021 Proposed budget. Scott talked about the step program that the teachers' follow. The step program is from the teacher contract for the Governor Wentworth district. The committee did not agree with the 11.93% increase. Traci Donovan-Laviolette proposed a flat amount of \$1,000,000 for the wage line. The committee agreed to a 3% increase. The budget committee discussed lines 211-260 and agreed to the school board's 2021 proposed figures.
