**Article 1:** To nominate and elect officers as follows: one Commissioner for the term of three years and until a successor is duly authorized, one Auditor for the term of three years and until a successor is duly authorized.

**Article 2:** To see if the Village District will vote to raise and appropriate the sum of \$66,788 for operating expenses as follows:

Dam Registration Fee	\$ 1,500
Bond Debt (Principal & Interest due 8/22)	\$ 35,744
Bond Debt (Interest paid 2/22)	<u>\$ 744</u>
Total	\$ 66,788



**Article 4:** To transact any other business that may come before this meeting.


