Some panels are 320 feet long. The areas between and outside of the panels will be grass. Maintenance of the grass is one to two times a year.

Effect storm water run off:

Large scale projects are new there is not much guidance through the state

There is 20ft between panels that will be grass.

Run off is gathered off the panels and moves over the earth it is gathered and channeled at an area on site for treatment and construction in flow in which the flow needs to be balanced.

Storm water pond=pipe system=level spraying.

Construction materials are managed on site, includes sediment control package (silk socks, mulch burns) Migration still takes place and erosion control.
