Board reviews the email from legal counsel, J. Hotchkiss does not feel that the town should forgive the penalties. J. Mullen feels that we should not set precedence. He is looking to increase electrical to \$50.00 for resident and \$100.00 for commercial. J. Mammone would like to increase occupancy to \$25.00. J. Mammone would like to add a fee to demolition. J. Mammone would also like to add fees to re-inspection. J. Mammone will bring a fee schedule to the next meeting.
