• 10/24/2022: C. Maynard made a motion to accept minutes as written, R. Tufts-Keegan seconded, motion passed.

Signature Action:

• <u>Strafford County Commissioners County Tax Acknowledgement</u>: Acknowledging receipt of the County Tax Invoice for \$609,281.00, payment due date of 12/17/2022.

Old Business:

• Personnel Policy: C. Maynard reported further discussion with legal regarding revamping the entire policy. Lawyer to review policy, flag any issues and meet with the Selectmen Thanksgiving week. The hope was to roll out new policy at the beginning of 2023, legal said that is not a reasonable expectation. Due to that, C. Maynard made a motion to interpret the earned time policy the way it was presented upon hiring the Road Agent, to increase to 3.08 hours per week after completing one year of employment. R. Tufts-Keegan seconded, motion passed 2-1. L. Parker stated for the record that she supports fixing what is wrong, however she believes this was a hasty decision.

New Business:

- NHMA Legal Client File Retention (prior to 2015): R. Tufts-Keegan would like to see what the files are, if any. C. Long to request the files are sent to the Town for review instead of being destroyed.
- <u>Deeded Properties (for Non-Payment of Taxes)</u>: The prior Tax Collector deeded four (4) properties for failure to pay taxes. (list attached)

 seconded, motion carried.

• <u>Appointment (Planning Board)</u>: C. Maynard made a motion to appoint John Mullen from an alternate member to a regular member of the Planning Board, L. Parker seconded, motion carried.

Public Comment:

<u>Dan Saliga</u>: Requested an update on Town Clerk/Tax Collector Services. R. Tufts-Keegan answered that our new clerk will be taking the DMV class in December. Wakefield with continue Motor Vehicle transactions, with temporary help performing Motor Vehicle transactions on Wednesdays here.

Requested an update on Chief Cooper's return. R. Tufts-Keegan responded there is nothing to report at this time.
