10. Fire/EMS

Minutes:

For the month of April Middleton Fire & Rescue had 60 calls. The April storm broughe in 47 Fire calls that range from tree on the wires to welfare checks. We had crews out from 4 AM to about 12 AM the following day assisting the town and line crews to get to where they were needed. We had 3 mutual aid calls from other departments to assist with building fires and brush fires. There wer 10 medical emergencies of which 3 were covered by us. These occurred mostly during the day. In April we trained in wildland forestry firefighting. I personally would like to than every member of the department for making this department what we are. If you wild like to join the department we are always looking for new members, please send me an email or contact anyone in the department or come down to the department on Tuesdays at 6:30 PM. No experience necessary. I encourage anyone to reach out if you have any questions. Chief Laviolette stated: There were a few comments for the Highway departmen stating they did a phenominal job. Thanks to the department for what they do. The open house was a hughe success. They got 3 new applicants.

11. Highway Dept

Minutes:

April 8 thru May 13. Cleared roads of trees & limbs after storm. Graveled & raked New Durham Road. Filled pot holes Gary Rd. Took telephone line out of silver street. Put stop signs up Butler Milk & New Durham road, Pheasent & Partridge road. Put Tufts Road sign back up. Cut & chipped down trees & limbs side of roads. Called 3 companies on parking lot job at the Old Town Hall. Sent list out for pricing on paving for this. Called for fuel pump annual inspection. Dan Phillips got drawn for random drug testing. Ordered 20 new flags. Picked up hot top chunks at the Old Town Hall and raked. Took pump readings for April. Changed tires over to summer ones. Changed oil in mower & prepped. Ordered chemical toilet for town beach. Mowed lawns for first time. Cleaned up town beach. Called 3 companies back to check on progress on Old Town Hall paving. There were a few comments for the Highway departmen stating they did a phenominal job. Thanks to the department for what they do.

12. Police

Minutes:

The Police department had 64 incidents, 1 arrest, 1 accident and 75 motor vehicle stops. The police department also assisted with removing trees, branches and debris from roadways which was caused by the heavy snowall at the beginning of the month.
