 - 1. Kim Hughes explained that it didn't represent all the employees, only the ones who had turned in their form

7. Purchase Authorization -Fire

- 1. Middleton Chief Jarrod Wheeler requests funding for critical SCBA equipment upgrades.
 - 1. 3 quotes were presented

- The chief explained the biggest difference in pricing is that the cheapest quote is the actual manufacturer for all three, and the only difference would be not having the logos on the bottle
- 2. Looking to spend \$6,320 out of the Capital Reserves account (SCBA Replacement line), which should have about \$70,000 in it. (See attached)
- 3. Tracy Donovan-Laviolette motions to approve the request
- 4. Bonnie Gagnon Seconds
- 5. The motion passes unanimously by all present board members.
- 2. Middleton Chief Jarrod Wheeler requests funding for supplies to update the Middleton Fire Dept. building.
 - 1. Members will be doing all the actual work
 - 2. Looking to get up to \$5,000 from the New Edition CRF
 - 3. Bonnie Gagnon moves to accept the chiefs request
 - 4. Tracy Donovan-Laviolette seconds the motion
- 3. Kate Buzard asks what the plan for Smokey the Bear (sign outside Old Town Hall)
 - 1. Chief Wheeler states that because it is rotted they are looking into replacing it one made from another material, perhaps metal.
- 4. Kate Buzard asks if the Middleton Elementary School is a certified emergency shelter.
 - 1. Chief Wheeler explains that it is a tricky question because it doesn't have a generator (a grant to get a generator for the school is underway)
 - 2. The county public health network has trailers that have all the shelter materials and would only take a phone call for them to be mobilized on the scene if needed.

8. Waste Management Presentation

- 1. Pete Lachapelle from Waste Management came to discuss the feasibility of Waste Management taking over our town's trash services.
 - 1. He would need to have a gross tonnage from the last two years before any final numbers could be discussed.
 - 1. Timothy Cremmen is getting that information for him.
 - 2. He also discussed plans for transitioning to automated collection services for trash pickup, including equipment details and cost implications.
 - 3. The discussion also included the benefits of this model and reassured the board about ongoing support and maintenance of the containers.

- 4. It was determined that he would return with one of the containers for the board to review.
- 5. Kate Buzard inquired about recycling options and the ability to drop off in Rochester at their facility.
 - 1. It was explained that the service is only for the host community and would not be available to Middleton.

9. Jim Keegan

1. Even though Jim Keegan was listed on the agenda, he was not present at the meeting. The board was unaware of the specific topic he wished to discuss, other than that it concerned the Highway Department

10. Budget committee hearing

- 1. According to Bonnie Gagnon, procedural errors require the rescheduling of the public hearing for the Collective Bargaining Agreement (CBA) involving the MES School Board and MEA teachers. Ms. Gagnon asserted her belief that the Budget Committee Chair did not adhere to the necessary deadlines for public notification. She also noted that the notices that were posted incorrectly referred to the event as a "Special Meeting" instead of the required "Public Hearing," underscoring the importance of compliance with all procedural timelines for such hearings.
- 2. Tracy Donovan-Laviolette indicated that her previous remarks were no longer relevant. She had intended to discuss the possibility of the board canceling or rescheduling their meeting to enable members to go to the Budget Committee's Public Hearing. However, since it appeared there might not be a meeting, she felt there was no longer a need for that discussion.

11. Town Communication

 To ensure all members have adequate time for a detailed review, the Select Board has tabled the communication policy that Timothy Cremmen has been working on and recently sent to them.

- Jonathan Sindorf inquired how the Chair of the Budget Committee would be notified about the need to reschedule the Public Hearing if they were not currently watching the meeting.
 - 1. Bonnie Gagnon led a discussion on how frequently the Chair checks their email and the probability of it being seen.
 - 2. Timothy Cremmen suggested that the most effective approach would be for the Budget Liaison to contact the School Board Liaison, Nicole Huntress, to inform them of the situation.
- 2. Tracy Donovan-Laviolette asked if there were any other comments about Waste Management's presentation
 - 1. Valerie Burke discussed the size of the containers
 - 2. Kate Buzard discussed the need for recycling
 - 3. Bonnie Gagnon discussed the impact of seasonal residents
 - 4. Kim Hughes discussed the durability of the containers


