Meeting was called to order by R. Tufts-Keegan at 5:15 PM

4. Non-Public Session Minutes

Minutes:

Fire Chief Mike Laviolette requests copy of minutes from non-public session on February 6, 2023. Motion to unseal minutes made by L. Parker, seconded by C. Maynard, motion passed. Minutes were read in public session (attached).

5. Fire Chief

Minutes:

Fire Chief Laviolette's Conditional Offer Letter required completion of his EMR within 6-months of the Letter dated August 19, 2022. He was unable to complete that requirement. At the February 6, 2023 non-public session the BOS and Chief discussed next steps. After the meeting, there were mixed perceptions as to what took place, which resulted in needing to revisit the matter in another non-public session, which Chief Laviolette requested being held in public session.

Chief Laviolette thanked the Board for revisiting the matter and stated he wants to find a resolution. He has found an EMT-Basic class in Epping on 5/25 and a EMR class in Concord on 5/10. The EMR class is 100% funded by grants and would be no cost, however he feels the EMT-Basic class will suit the Town's needs better. The classroom portion of EMT-Basic finishes on 7/21, with practical portion after and finally the test. The Chief is confident he can pass the EMT-Basic given the opportunity.

R. Tufts-Keegan stated she think Mike is doing a good job as Chief and likes that he was willing to re-visit the issue to find a resolution that works for everyone.

- C. Maynard said she was sad to see Mike be willing to walk away and is glad he is willing to stepup and take the course.
- L. Parker said last week's discussion was nothing to do with job performance, simply the fact that the agreement conditions were not met.

Chief Laviolette said he was caught off guard, not aware of what the non-public was about and didn't have class information available.

Chief Laviolette stated that by the end of the year he should be able to take the test. BOS will provide a new conditional offer stating he will sign up for the next available EMT-Basic class, Chief Laviolette will pay the \$1,600 fee out of pocket and upon successful completion the Board will revisit reimbursement options.

Dan Saliga got up to speak about rumors and was asked to sit down.

Tracy Donovan-Laviolette spoke about the surrounding towns and their license requirements for Chief and the liability of having our Chief holding a lower license than his people. Wants to know what research the Board has done about this?

L. Parker stated that the Fire Chief Job Description requires a EMT certification and she is not sure where the EMR came from in his original offer letter.

Tracy Donovan-Laviolette stated a Selectman at the Tuesday night Fire Dept meeting stated "I didn't think you were telling the personnel you were terminated yet?" Wants it made clear the word "termination" was used, which is why the public was so upset over this situation.

- C. Maynard admitted to using that term and R. Tufts-Keegan stated it was a poor choice of words.
- A. Bowden understands not paying for classes however she thinks it is a very poor decision to not pay for the Chief's class in this case after he has given over 20 years of service to the Town.

Susan Dunn: In the spirit of retention, would the Board consider not only paying for the course for the Chief, but even consider paying for new hires to take the course?

L. Parker stated we have been paying for courses over and over for several years for many people. It will be up to the Board at the time he passes whether to reimburse.



Public Comment

R. Tufts-Keegan reminded everyone voting is March 14th and Town Meeting is March 18th.

Tracy Donovan-Laviolette: Questions a missing section from Public Comments in the Minutes from February 6th regarding a comment made regarding a Dept Head. C. Long responded she wasn't sure what Tracy was referring to but she must have missed it and if Tracy tells her what it is then she will add it. Tracy responded it was regarding a Dept. Susan Dunn: Now that Sgt. Swift left, do we have police coverage? R. Tufts-Keegan responded yes we have coverage.

Susan Dunn: How many officers do we have? R. Tufts-Keegan responded two.

Susan Dunn: Who oversees the department? R. Tufts-Keegan responded the Chief of Police.

Susan Dunn: Will someone show up if I call 9-1-1? R. Tufts-Keegan responded you will call and Strafford County Dispatch will dispatch an officer to your house, whether it is a Middleton Police Officer, surround area officer or State Police.

Griffin Parks: Stated he works at Dispatch and there will always be someone to respond.

C. Maynard: It is just like a medical emergency if there is nobody on call we would get mutual aid.

Mike Green: Who are the two police officers? R. Tufts-Keegan replied Chief and Officer Volpe. We have two part-time officers.

Mike Green: How often to part-time officers work? R. Tufts-Keegan said it varies. C. Maynard said

last time she spoke with Sgt. Swift about this he said sometimes it is one shift a month, sometimes more, it depends on their schedule.

Bonnie Gagnon: Are the roads posted? New Durham posted theirs today. Jim Keegan responded they have asked the logging operation not to haul Thurs or Fri due to warmer temps and they will reevaluate at the end of the week. Dan Phillips added Milton and Farmington posted as well.

Jason Proulx: Regarding the Police, understand not releasing sensitive information, but sooner or later someone is going to have to answer the people's questions. R. Tufts-Keegan responded what question do you have and I will answer the best that I am allowed.

Jason Proulx: Is there a time expected for Chief to return? R. Tufts-Keegan we can not answer that.

Susan Dunn: Is there a reason we don't have an interim chief? R. Tufts-Keegan stated there is an RSA that governs the Police Chief and we are working within those guidelines.

Susan Dunn: Are you at least working to staff more officers? R. Tufts-Keegan stated that is the Police Chief's responsibility per the RSA.

Susan Dunn: How long has the Chief been out? R. Tufts-Keegan responded since June.

Susan Dunn: So we don't get a Dept report since June? R. Tufts-Keegan responded no, we were getting the Dept Reports, Sgt. Swift had been providing them, we just don't have one for January. Susan Dunn: Will Officer Volpe be providing one in the future? R. Tufts-Keegan answered we can

ask him to do one, but we can not required him to.

Susan Dunn: Could you give him a stipend to do it? R. Tufts-Keegan responded we do not govern that department, it is governed by this RSA which is headed by the Chief of Police.

Joanne Coskie: If the Police Chief is not here to govern then who is? L. Parker stated we have asked the same question.

Joanne Coskie: Do we have anybody who is in charge of that Department? R. Tufts-Keegan answered these are all questions we have and are working with outside counsel on it.

Brian Taylor: Are any full time officer positions posted right now? R. Tufts-Keegan answered we as the Board of Selectmen can not hire in that department, that is the Chief of Police's job under the RSA.

Joe Bailey: Basically, when the Chief is not here responsibility goes to the 2nd in command to operate the department only. As far as the Chief, he is out on medical and because it is medical they can't talk about it. The Chief is a very protected position per RSA by the State of NH.

Dan Phillips: Gave monthly report (attached) Discussion about Logging on Jordan Drive and paper roads. Paper Roads are roads proposed by contractor and shown on tax maps, but not built. Recommending to have logger get the land surveyed, then cut the road to log their property. It would give access to the five lots owned by the Town.

Dave Deufresne: Will we get trees they log off Town property to make road? Dan Phillips responded that it up to the Board of Selectmen.

John Sindorf: Questions what benefit there is to the Town to allow them access, besides little bit of timber tax? Believes it is cheaper to own land than to allow it to be subdivided.

Joanne Coskie: Do you know the approximate length of the road. Dan Phillips responded approx. 500 feet.

L. Parker: The Town can say no. Dan Phillips stated he's not here to say yay or nay, just giving facts.

Randy Talon: Doesn't believe you can say no, it's is a class IV road, it's an easement from a subdivision designed in the 60's

Bonnie Gagnon: Is there any other way they can access this land? Dan Phillips responded not that he is aware of. R. Tufts-Keegan replied you could look at the deed.

Brian Taylor: Would like a copy of logger's proposal since he is an abutter.

Others present during non-public meeting was Michael Laviolette.

Discussion held regarding the EMR requirement of Michael Laviolette's agreement signed with the town when offered Fire Chief position. Michael Laviolette was given 6 months to obtain the EMR certification. Michael states that he did not pass his EMR test and would have to take another entire class and retest. He stated how he has been busy in his personal life and does not feel like it is obtainable. Roxanne Tufts-Keegan mentions the possibility of him getting enrolled in another class within the next two months and obtaining the license within a time frame. Michael would have to pay for the class himself but if he passed the BOS could review a possibility of reimbursement. Michael mentions possibly taking and EMT Basic class. Laura Parker asks why take a harder class if he did not pass the EMR and the basic class and testing requirements are harder. Michael states that he believes the class material and the test are the same for both. Laura Parker asks Michael if he thinks that that is obtainable within a year. He can not guarantee that he would pass and obtain the required license within the year, it may take a year or more. Laura Parker mentions how you do not want to waste money and set yourself up for failure, if one class was hard this one may be harder. Laura Parker asks Michael about the agreement he signed that expires around February 19th and how the agreement stated he would obtain the EMR license within the six months. Michael acknowledged that he signed the agreement but was unable to pass. Laura Parker asked Michael if he was in the BOS shoes and had this agreement that was not followed through, what would he do if he was in our shoes. Michael stated he would fire himself. Christine Maynard states how that is not what the board wants. Roxanne Tufts-Keegan talks about the possibility of removing that requirement. Laura Parker mentions how all the BOS hears about is the need for EMS licenses on the department, and paying Milton, why would the BOS remove a requirement that would help the town and fire department.

Michael stated that Jeff Eldridge was ready to step in at any moment. He also states that the Town should consider hiring a part time Fire Chief and pay them about \$20,000 a year. Laura Parker states how that is not something we can just do now on a whim, and we cant even find per-diem employees who would want to be the part time fire chief.

Michael states that he knows of someone already. Laura Parker asks who? He states Jeff Roub is willing to come over and be the part time fire chief. Laura Parker reminds them that Michael also said Jeff Roub was going to sign on for the per-diem shift and to date we haven't had an application. Discussion was held on other members on the dept that would be willing to step in as interim chief. Jake Bordeau? Michael said he wouldn't do it. Laura Parker stated they could at least talk to Jake. Michael again mentions Jeff Eldridge. Christine Maynard said she would talk to him. Christine Maynard also said this is not what the board wants to do, but the agreement has not been followed through and on the 19th we will have no Chief. Michael states how he understands that the board has to do what they have to do and he has no ill feelings. Board will find an interim Chief until another decision is made.
